

<u>Certificate of Achievement for Excellence in Financial Reporting Program</u>: The City of Janesville received this award for fiscal year 2020. This marks the 28th consecutive year the City has received this award.

Award for Outstanding Achievement in Popular Annual Financial Reporting: The City of Janesville received this award for fiscal year 2020. This was the third consecutive year the City received the award, which is a prestigious national award recognizing conformance with the highest standards for preparation of state and local government popular reports.





**2021 Community Improvement Award:** Forward Janesville, Inc. selected the City of Janesville as one of four co-recipients of the 2021 Community Improvement Awards. The City received this award for its efforts during the Interstate 39/90 Expansion Project.

**HPL Named 2021 Educator of the Year**: The Hedberg Public Library received a community honor when Forward Janesville, Inc. announced they had selected the library as their 2021 Educator of the Year. In 2021, over 15,000 people of all ages attended library classes and programs.



Statewide Project of the Year: The American Public Works Association-Wisconsin Chapter announced that the City's West Milwaukee Street Bridge project had been awarded its 2021 Small Cities/Rural Communities Project of the Year. This honor is given to a public works project in a city or county with a population of 75,000 or less that demonstrates creativity, ingenuity, and efficiency in the delivery of public works projects that have a profound impact on the community.

<u>Tree City USA</u>: Wisconsin's Park Place was named a 2021 Tree City USA by the Arbor Day Foundation for the eighteenth year running. Janesville, which prides itself on its parks, has received this special designation every year since 2004.



<u>JTS Receives Perfect Federal Review:</u> The Janesville Transit System received zero findings from their Federal Transit Administration's Triennial Review of the agency. A deficiency-free review is considered a rare and exceptional achievement. The review examined 21 key review areas, including financial capacity and management, technical capacity, ADA and Title VI compliance, among other categories.

<u>Senior Center Reaccreditation</u>: The Janesville Senior Center received reaccreditation status through the Wisconsin Association of Senior Centers (WASC). The WASC first accredited the Janesville Senior Center in 2011 and reaccredited it in 2017.




Wisconsin's Park Place offers diverse opportunities with its 2,609-acre park system, which includes 64 improved parks. Janesville's parks are divided into categories that include regional parks, community parks, neighborhood parks, greenbelts, and open spaces. Regional parks are designed to provide recreational opportunities to all local residents and those from surrounding communities. Community parks are designed to serve residents within a radius of a few miles. Lastly, neighborhood parks are designed for the individual neighborhoods in which they are located. The various parks provide an arboretum, Lion's Beach, outdoor swimming at Rockport Pool and the Palmer Park Wading Pool, the Riverside Park Splash Pad, tennis courts, four lighted softball fields, sledding hills, ten miles of cross-country ski trails, 31 miles of paved bike trails, and picnic pavilions.

Economic Development facilitated Tax Increment Financing in 2021 to spur \$6.9M in investment, guaranteeing \$436,000 in annual property tax increment and \$19.2M in new property value.



The Assessor's Office completed a maintenance assessment roll in 2021. The next citywide revaluation of residential and commercial property is scheduled for 2023.



The Janesville Transit System will receive two replacement buses in July 2022 and has applied for funds for an electric bus pilot program.



JPD and the community experienced a 40-year low crime rate in 2021. 2021 also allowed the Department to revisit community outreach in an ongoing commitment to build community trust.



The Hedberg Public Library provided resources and services to the community through a main library, an Express Branch at the Uptown Janesville mall, and in neighborhoods via a Bookmobile.



The Housing Services Division and HUD initiated a Foster Youth to Independence Voucher Program to support local youth aging out of Foster Care.



The City utilizes five main fund types to account for governmental services. These funds are grouped into two separate categories: governmental activities and business-type activities. Governmental activities are the basic services provided by the City and include services such as public safety (police and fire); public works; parks and recreation; library; and general administration. Business-type activities include stormwater, water, sewer, and transit services. These are considered business-type activities because fees are charged to customers to cover the cost of providing these services.

### **General Fund**

The chief operating fund of the City, includes general government; public safety; public works; parks and recreation; neighborhood and community services; and economic development expenditures.

## **Special Revenue Funds**

Account for activities where dollars are restricted to specific purposes such as Hedberg Public Library, Tax Increment Financing (TIF) Districts, the landfill, and grants.

## **Capital Projects Funds**

Account for construction and acquisition of major capital assets including vehicles and equipment.

### **Debt Service Fund**

Account providing for the repayment of long-term debt associated with capital projects.


## **Enterprise Funds**

Account for the activities that operate much like a business in that services are supported by user fees such as the Water and Wastewater Funds.

This is a summarized report presented to citizens to better understand the City of Janesville's 2021 Annual Comprehensive Financial Report. This report is largely derived from the 2021 Annual Comprehensive Financial Report and utilizes the same measurement focus and basis of accounting. However, it is not prepared in accordance with generally accepted accounting principles (GAAP). The General Fund is the chief operating fund of the City and provides for municipal services that are primarily funded by property taxes.



### Revenues


In 2021, the General Fund received \$52,238,983 in revenue.

The chart to the left depicts the variety of revenue sources collected in the General Fund. The General Fund's largest source of revenue is from taxes at \$34,736,256, or 67%, followed by state and federal aids at \$9,200,713, or 18%.

# **Expenditures**

In 2021, the General Fund had \$51,324,102 in expenditures.

The chart to the right depicts the variety of programs funded by the General Fund. The General Fund's largest expenditures were for public safety (Police and Fire Protection) at \$27,062,521 or 53%. The next largest expenditure was for Debt Service, at \$9,571,360, or 19%.



In 2021, the difference between actual General Fund revenues and expenditures resulted in a \$914,881 increase in fund balance. The General Fund ended the year with a fund balance of \$11,132,340.



Property taxes are the City's largest source of revenue, used to pay for library and city-provided services such as police protection, fire protection, parks and recreation, snow removal, and much more. About two-thirds of the costs to administer City government and library services are funded through property taxes. The remaining non-property tax revenue comes from financial aid from the State of Wisconsin, user fees, permit fees, non-property taxes, interest, rents, or fines.

To the left is the average home's 2021 City tax bill broken down by cost per service per month. The property taxes by service percentages differ from page 10 as transfers, subsidies, and debt service are allocated to the corresponding services and each service is credited for program revenue. Once complete, the remainder is an allocation of the tax levy for each service.

The average home's \$90.41 monthly bill covers municipal government services, but does not provide state and county services. The property tax bill adds together the tax levy of four different taxing jurisdictions, not just the City of Janesville. Instead of requiring that separate bills be paid to each governmental unit, the levies from all four are combined into one bill. After the property tax bill is paid, the money is divided and each taxing jurisdiction receives its share. The distribution of property taxes by jurisdiction can be found below:

- City of Janesville = 33%
- School District of Janesville = 36%
  - Rock County = 26%
- Blackhawk Technical College = 5%













The Stormwater Utility, created in 2003, collects and conveys stormwater through the use of public streets, catch basins, storm sewers, detention/retention basins, and greenbelts. The system includes over 161 miles of storm sewers, 15 miles of drainage ways (including greenbelts), and 27 detention/retention basins.

### Revenues

In 2021, the Stormwater Utility Fund received \$5,895,967 in operating revenue.

The chart to the right depicts the revenue sources collected in the Stormwater Utility Fund. The Stormwater Utility's largest source of revenue is from User Charges at \$5,895,967, or 100%.





## **Expenditures**

The Stormwater Utility Fund had \$4,524,859 in operating expenditures in 2021.

The chart to the left depicts the expenditures of the Stormwater Utility Fund. The Stormwater Utility's Operating & Maintenance expenditures were \$4,266,635, or 93%, followed by Depreciation at \$258,224, or 5%.

In 2021, the difference between actual Stormwater Utility Fund revenues and expenditures resulted in operating income of \$1,371,108. The Stormwater Utility Fund ended the year with net position, which represents total assets less total liabilities, of \$10,730,645. This is a \$1,310,276 increase in net position from 2020.





The Water Utility manages the water distribution system, which consists of a network of over 372 miles of water mains. The water supply for the City of Janesville includes the operation and maintenance of eight wells, three booster stations, two water storage reservoirs, and one elevated tower.

### Revenues

In 2021, the Water Utility Fund received \$14,175,292 in operating revenue.

The chart to the right depicts the variety of revenue sources collected in the Water Utility Fund. The Water Utility's largest source of revenue is from Residential Users at \$6,296,170, or 40%, followed by Industrial Users at \$3,131,770, or 20%.





## **Expenditures**


The Water Utility Fund had \$5,603,547 in operating expenditures in 2021.

The chart to the left depicts the variety of programs funded by the Water Utility Fund. The Water Utility's largest expenditures were for Depreciation at \$2,087,395, or 27%, and Payment-in-Lieu-of-Taxes (PILOT) at \$1,636,149, or 21%.

In 2021, the difference between actual Water Utility Fund revenues and expenditures resulted in operating income of \$8,571,745. The Water Utility Fund ended the year with net position, which represents total assets less total liabilities, of \$61,630,487. This is an \$8,244,203 increase in net position from 2020.



The Wastewater Utility manages the sewage collection system, which consists of approximately 350 miles of sewer main. Additionally, the wastewater treatment plant, located off Afton Road, tests and treats sewage in a manner that complies with all state and federal environmental regulations.



### Revenues


In 2021, the Wastewater Utility Fund received \$11,105,352 in operating revenue.

The chart to the left depicts the variety of revenue sources collected in the Wastewater Utility Fund. The Wastewater Utility's largest source of revenue is from Residential Users at \$7,459,384, or 66%. This is followed by Commercial Users at \$1,817,143, or 16%.

## **Expenditures**

The Wastewater Utility Fund had \$8,962,662 in operating expenditures for 2021.

The chart to the left illustrates the variety of programs funded through the Wastewater Utility Fund. The Wastewater Utility's largest expenditures were for Depreciation at \$3,462,912, or 33%, and Operation at \$2,235,703, or 21%.



In 2021, the difference between actual Wastewater Utility Fund revenues and expenditures resulted in an operating income of \$2,142,690. The Wastewater Utility Fund ended the year with net position, which represents total assets less total liabilities, of \$59,122,185. This is a \$607,342 increase in net position from 2020.





The Janesville Transit System (JTS) offers bus service Monday through Saturday on six routes in Janesville, and operates the Beloit-Janesville Express on weekdays. "Dial-A-Ride" paratransit service is available for persons with disabilities who are unable to use the city buses.

### Revenues

In 2021, the Transit Fund received \$332,099 in operating revenue.

The chart to the right depicts the revenue sources collected in the Transit Fund. Transit's largest source of revenue is from Federal Operating Grants at \$1,536,879 or 39%, followed by City Operating Subsidy at \$957,411, or 24%.





## **Expenditures**

The Transit Fund had \$4,354,905 in operating expenditures in 2021.

The chart to the left depicts the expenditures of the Transit Fund. Transit's Operating and Maintenance expenditures were \$3,557,515 or 82%, followed by Depreciation at \$797,390, or 18%.

In 2021, the difference between actual Transit Fund operating revenues and expenditures resulted in operating loss of \$4,022,806. The Transit Fund ended the year with net position, which represents total assets less total liabilities, of \$13,251,553. This is a \$369,026 decrease in net position from 2021.




### Sanitation Fund

The Sanitation Fund received \$11,216,198 in revenue and had \$9,467,764 in expenditures, resulting in a \$1,748,434 increase in fund balance.



## Hedberg Public Library

The Library received \$4,167,719 in revenue and had \$3,966,201 in expenditures, resulting in a \$201,518 increase in fund balance.



## Oak Hill Cemetery

Oak Hill Cemetery received \$197,230 in revenue and had \$231,838 in expenditures, resulting in a \$34.608 decrease in fund balance.




## Golf Course

The Golf Courses received \$1,466,134 in revenue and had \$1,400,393 in expenditures, resulting in a \$65,741 increase in fund balance.







The charts below illustrate revenue and expenditure trends for the City's major operating funds: General Fund, Sanitation Fund, and Stormwater Utility Fund. The analyses provide comparative data for the past five years.



The General Fund experienced an end-of-year, positive net change in fund balance four of the last five years. The General Fund ended the year with a positive net change in fund balance of \$1,099,364 in 2018, \$144,278 in 2019, \$700,909 in 2020, and \$914,881 in 2021. 2017 experienced negative net changes to fund balance.

The Sanitation Fund experienced a positive net change in fund balance in three of the last five years. The Sanitation Fund ended the year with a positive net change in fund balance of \$1,434,751 in 2017, \$346,114 in 2020, and \$1,748,434 in 2021.







The Stormwater Utility Fund experienced an end-of-year, positive net change in net position from 2017 to 2021. The Stormwater Utility Fund ended the year with a positive net change in net position of \$742,649 in 2017, \$716,146 in 2018, \$574,188 in 2019, \$1,588,434 in 2020, and \$1,310,276 in 2021.



The charts below illustrate revenue and expenditure trends for the City's major operating funds: Water Utility Fund, Wastewater Utility Fund, and Transit Fund. The analyses provide comparative data for the past five years.


The Water Utility Fund experienced an end-of-year, positive net change in net position from 2017 to 2020. The Water Utility Fund ended the year with a positive net change in net position of \$1,491,317 in 2017, \$2,521,079 in 2018, \$894,881 in 2019, \$6,349,266 in 2020, and \$8,244,203 in 2021.





The Wastewater Utility Fund experienced an endof-year, positive net change in net position from 2017 to 2021. The Wastewater Utility Fund ended the year with a positive net change in net position of \$933,103 in 2017, \$456,806 in 2018, \$900,046 in 2019, \$151,313 in 2020, and \$607,342 in 2021.

The Transit Fund experienced an end-of-year, positive net change in fund balance in two of the last five years. The Transit Fund ended the year with a positive net change in fund balance of \$1,889,918 in 2019 and \$3,408,795 in 2020. The years 2017, 2018, and 2021 experienced negative net changes to fund balance.





The City of Janesville provides two financial transparency websites, Open Budget and Open Expenditures. The websites represent an ongoing coordinated effort by the City of Janesville to cultivate an open and transparent local government for the community.


Open Budget offers a guided view through the financial complexities of the City of Janesville annual budget and includes data for 2008 through the current year. Open Expenditures contains all City expenditures including payments made to vendors and other obligated parties by the City of Janesville for 2010 and beyond. Users can search to find information about certain vendors or accounts, or drill down to see the budget and expenditures of specific programs such as snow removal or fire prevention.


