ARTICLE VIII. CIRCUS, EXHIBITION, ENTERTAINMENT, THEATRICALS AND THEATERS

Sec. 12-220. License; required; fees; exceptions.

No person shall exhibit or give any public theatrical or operatic performance, musical entertainment, circus, menagerie, or other show, exhibition, entertainment, performance or amusement whatsoever, without having obtained a license therefor under the provisions of this chapter; provided, however, that exhibitions and musical or other entertainments may be given without obtaining a license therefor when the profits derived therefrom are to be used in the City for charitable or benevolent purposes. The license fee shall be in an amount as established by the City Council from time to time and as set forth in the fee schedule that appears in this Code.

Sec. 12-223. License application: information required.

Any person desiring to obtain a license pursuant to Section 12-220 shall make application therefor to the City Clerk. Such application shall specify the character of the performance, exhibition, entertainment or amusement for which a license is desired, the name and residence of the applicant, and the price to be charged for a single admission, but the price of admission need not be stated in any application for an annual license. Each such applicant shall state, in such application, the number of cars which are to be used in the transportation of its property and equipment.

Sec. 12-224. - License; application; Council approval; time limit.

Upon the filing of an application pursuant to <u>Section 12-223</u> with the City Clerk and the payment of the proper license fee, the City Clerk shall transmit such application to the City Council at its next regular meeting. If a majority of those present at any such meeting of the Council votes in favor of granting such license, then the City Clerk shall issue to such applicant a license for the period of time for which payment has been made, but not for any length of time greater than the time authorized by the Council.
