Purpose of Meeting

The Purpose of today's Forum is to provide the community with information about the proposed Fisher Creek Trail Projects and to receive feedback for use in the design process. The forum will begin with a brief presentation shortly after 5:30 p.m. Representatives of the City of Janesville and the design team will be available after the presentation to answer questions, explain exhibits, and provide additional information regarding the project.

PROJECT INFORMATION

Phase 1 – W. Court Street to Dartmouth Drive (WisDOT ID #5990-03-14)

The City of Janesville and the Wisconsin Department of Transportation propose constructing a 10-foot-wide paved off-road trail with an approximate project length of 0.80 miles. The alignment will start at the existing path north of W. Court Street along Austin Road and travel north to Dartmouth Drive. This project will also include a trail connection to Greenway Point Drive and improvements at the Mineral Point Avenue crossing. The entire project will be located within the City's greenbelt and right of way. This project is a federally funded Transportation Alternatives Program (TAP) project administered by the Wisconsin Department of Transportation.












Phase 2 – Rockport Road to W. Court Street (Project #URGP623170)

The City of Janesville and the Wisconsin Department of Natural Resources propose constructing a 10-foot-wide paved off-road trail with an approximate project length of 0.62 miles. The alignment will start at Rockport Road and travel north to W. Court Street. This project will also include improvements at the W. Court Street crossing that include a Rectangular Rapid Flashing Beacon (RRFB). The trail will be located within the City's right-of-way and a bike trail easement along Fisher Creek. This project is a state funded Stewardship Project administered by the Wisconsin Department of Natural Resources.
