Contractors will be responsible for the following conditions:

1. The contractor shall notify the Building Division a minimum of three days prior to opening any street excavations. If required by the Traffic Engineer, the contractor shall submit a traffic control/signing and detour diagram for approval. Traffic control devices shall comply with the Manual on Uniform Traffic Control Devices (MUTCD) and be in place prior to commencing work.
2. Prior to excavating the street, the contractor must obtain a Plumbing Permit per City Ordinance 10-55, in addition to this plumbing street cut permit.
3. All plumbing installations in the ROW shall meet COJ Standard Specifications. All plumbing installations beyond the ROW shall be installed per Wisconsin Plumbing Code.
4. When a full street closure is authorized, the Engineering Department will notify Police, Fire, Transit, Operations, and the 911 Center. The contractor *may* be directed to notify and coordinate his/her work with affected adjacent businesses and property owners.
5. Tunneling under the curb & gutter or sidewalk is not permitted. Curb & gutter and sidewalk must be removed with the trench excavation.
6. The excavation shall be backfilled per COJ Standard Specifications.
7. Barricades and traffic control shall be left in place until the temporary or permanent patch is completed.
8. The saw-cutting of pavement shall extend a minimum of one foot beyond the disturbed trench area.
9. All pavement and curb & gutter restoration shall be installed to COJ Standard Specifications.
10. Corrective measures needed to repair sidewalk, curb & gutter, or pavement at a trench/pavement "cut" that noticeably settles due to poor compaction methods within the 1st year after placement will be billed to the Plumbing or Demolition Permit holder.
11. The applicant, his successors, or assigns, agrees to hold harmless the City of Janesville, its duly appointed agents, and employees against any action for personal injury or property damage sustained by reason or exercise of this permit.

- 12. All damages to the street shall be repaired and the roadway surface shoulders, slopes, ditches, etc., shall be restored to a condition acceptable to the City of Janesville City Engineer.
- 13. Any dirt, stones, etc., put on the roadway by the applicant, his successor, or assigns, must be cleaned off by the applicant, his successors or assigns IMMEDIATELY.

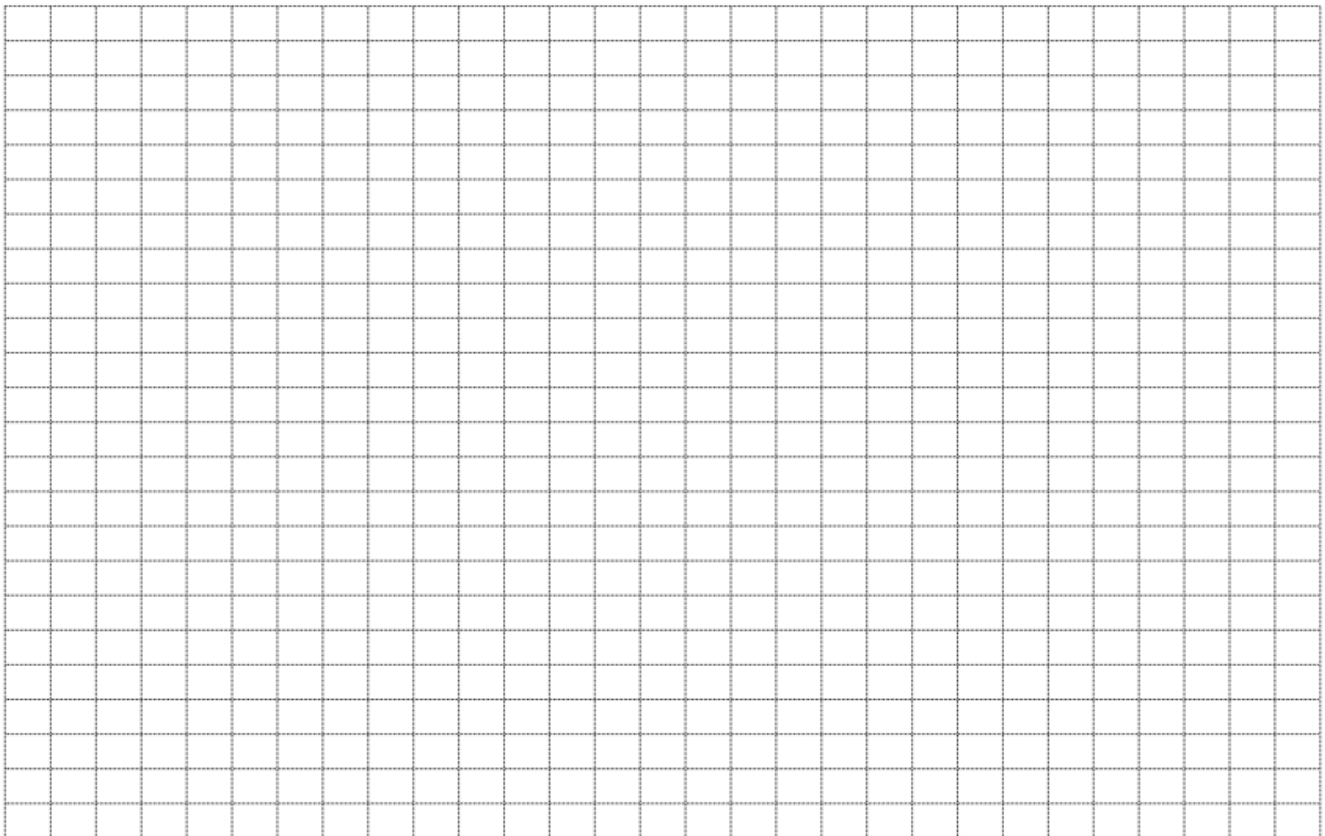
