On a motion by Member Schmidt, seconded by Member Weber, the TAC unanimously agreed to forward a recommendation to the Policy Board affirming the inclusion of the 11/14 bypass in the USH 14/STH 11 EIS.
- 3. **Review and approval of STP Urban Project(s).** Terry Nolan, MPO Coordinator, gave a report, explaining the difficulty in using the adopted process to evaluate STP submissions. Member Schmidt stated Milton plans to apply for Transportation Enhancement funds, thereby withdrawing the bike trail project from evaluation. Committee members suggested revising criteria to give more importance to pavement condition and volume. Janesville city staff ranks Main Street as a higher priority than Austin Road. Members also suggested creating a formula for allocating STP funds in an equitable manner between Janesville and Milton. On a motion by Member Weber, seconded by Member Saunders, the TAC directed Terry Nolan to revise prioritization procedures. On a motion by Member Weber, seconded by Member Schmidt, the TAC unanimously approved the Main Street project as the next STP project.
- 4. **Review and Approval of amendments to 2010-2015 Transportation Improvement Program.** Terry Nolan, MPO Coordinator, explained the addition of a state resurfacing project and the programming of transit projects. The amendment also designates Main Street as the next STP project and adds Austin Road into the TIP. # III. Approval of October 5<sup>th</sup> minutes

On a motion by Member Brandeen, seconded by Member Robinson the October 5, 2010 MPO meeting minutes were unanimously adopted.

# **IV.** New Business

1. **Review and approval of amendment to 2011-2016 Transportation Improvement Program.** Terry Nolan, MPO Coordinator, explained the projects to be added to the 2011

TIP. On a motion by Member Soltau, seconded by Member Robinson, the TAC unanimously approved amendments to the 2011-2016 Transportation Improvement Program.

V. Other items for discussion. Terry Nolan gave an overview of the Long Range Transportation Plan update document and how environmental consultation and freight rail will be incorporated into the document. Members then discussed recommended projects included in the Plan and rail. Members Saunders and Sweeney oppose the east-west grade separation project due to its impact on agricultural industry. Member Cherek gave a history of why the project was originally proposed, and that the feasibility of the project would be determined during planning and design for the I-39/90 expansion. He added that both this project and the Milton-Shopiere project are long range planning recommendations and it is important to identify those possibilities well in advance. Member Benjamin asked if comments and concerns from the towns are considered in the planning of projects and Member Cherek stated all long range planning recommendations would occur with the major update to be completed in two years.

Member Mumma discussed the South Central Wisconsin Commuter Transportation Study (SCWCTS) and the results that could benefit freight rail planning. The study also prompted a joint resolution by the Janesville area and Beloit area MPO's to preserve rail corridors. Member Mumma talked about the possible disinvestment by Union Pacific, as they are seeing less traffic on the Janesville to Chicago line now that General Motors is closed. Member Benjamin suggested we receive a presentation by Fitchburg representatives regarding how communities go about owning railway.

Previous to the meeting, Terry had asked Member Sweeney to help find a freight representative to serve on the Technical Advisory Committee and Member Sweeney asked Ken Lucht with WSOR. Ken Lucht is willing to serve and will be attending the next TAC meeting.

Bryan Meyer, Chairman of Milton Township, requested the MPO extend its planning boundary to include Newville Road north of HWY 14. The Town has been unsuccessful in receiving funding for maintenance of the road. Member Cherek replied that the 2010 Census would result in a redrawing of planning boundaries, and this may be a good opportunity to explore the inclusion of the road. MPO staff will look further into the matter.

Alan Arndt, LaPrairie Township Supervisor, brought up the need for interchanges at the intersections of HWY 11 and CTY G and HWY 11 and HWY 51. Member Cherek replied that a new study being conducted by WisDOT will consider improvements along state HWY 11 for that area located between Monroe and I-39/90. Within the Janesville are, those intersections will be studied. Member Marcos said the HWY 11/14 study will also consider improvements to the intersections, and the study may need to be sped up due to the approval of the I-39/90 expansion.

# VI. Adjournment

A motion to adjourn was made by Member Coopman, with a second by Member Payne. The January 4, 2011 TAC meeting adjourned at 11:30 A.M.

# III. Approval of January 4th minutes

On a motion by Member Sweeney, seconded by Member Weber the January 4th MPO meeting minutes were unanimously adopted.

#### IV. New Business

1. **Review and approval of amendment to 2011-2016 Transportation Improvement Program.** Terry Nolan, MPO Coordinator, explained the projects to be added to the 2011

- TIP. Alexis Kuklenski mentioned TIP numbers need to be added to the state projects. On a motion by Member Mumma, seconded by Member Levitt, the TAC unanimously approved amendments to the 2011-2016 Transportation Improvement Program with needed correction.
- 2. **Review and approval of amendment to 2011 Work Program.** Terry Nolan, MPO Coordinator, delivered staff report detailing the scope of the project change. Ben Coopman, Rock County Highway Commissioner, asked how the towns and county would be involved in the process. There was discussion about the scope of the project and the need to keep the project within budget constraints. It was determined to be logical to keep the focus of the project within the urban area. Member Levitt motioned to approve the Work Program amendment with the change to expand the scope of work to include county road segments within the urbanized area. Member Mumma seconded. Motion passed unanimously.
- 3. **Review and approval of 2005-2035 Long Range Plan Update memorandum.** Terry Nolan, MPO coordinator, gave an overview of the document and explained the results of the traffic forecasting. Member Weber requested the Long Range Plan incorporate the need for I-39/90 interstate crossings. Member Mumma agreed, saying the interstate is a hindrance for transit routes. There was discussion regarding whether the Plan should call out specific crossing recommendations. Member Weber motioned to amend the LRTP update memorandum to include a recommendation that, during the design of I-39/90, the MPO work with WisDOT to review the adequacy of crossing within the MPO for all modes of transportation, and specifically Bell Street and potential crossings between HWY 14 and Mt. Zion. Member Levitt seconded. Motion passed unopposed. Member Weber then made a motion to approve the LRTP update memorandum as amended and forward to the Policy Board. Member Mumma seconded. Motion passed unopposed.
- V. Communications from members. Member Marcos explained WisDOT may be speeding up the state corridor studies currently underway in the MPO region in order to coincide with the I-39/90 expansion. Member Weber said WisDOT mentioned the reconstruction of HWY 14 from Deerfield to STH 26 may be accelerated due to the I-39/90 reconstruction, but he did not know what the accelerated schedule would be. Member Canon said the I-39/90 reconstruction will have major impacts on local roads as traffic is rerouted, and that the I-39/90 project will include funds to mitigate impacts. Possible mitigation may be traffic signals, turning improvements and transit service.

A motion to adjourn was made by Member Coopman, with a second by Member Canon. The April 19, 2011 TAC meeting adjourned at 11:25 A.M.

I would like to provide some information for the Janesville Metropolitan Planning Organization during this public comment period to help with updating the 30-year Long-Range Plan for Janesville growth. Pioneer Hi-Bred International, Inc. is a wholly owned subsidiary of E. I. DuPont de Nemours and operates an office and 120 acre research farm in Section 1 of La Prairie Township. We rent around 150 additional acres in Harmony and La Prairie. Pioneer opened the Janesville corn research center in 1982 for the purpose of developing improved field-corn hybrids for the upper Midwest. Pioneer leaders in the late 70's realized the importance and potential of conducting corn research on the Rock Prairie, east of Janesville. Our farm consists of Plano Silt Loam, which is one of the most productive prairie-soil types in Wisconsin. Hybrids identified with superior performance on Plano Silt Loam will generally yield well on many of the other soil types found in this state. It is an excellent soil for delivering quality research data for plant breeding to improve genetic gain and yield. We do have numerous examples of Pioneer's long-term research commitment to a community and corn-growing area, such as the establishment of our Algona, IA and Princeton, IL centers in 1938, Mankato, MN in 1958, Union City, TN in 1955, Garden City, KS in 1978, York, NE in 1957, Kekaha, HI in 1968, Windfall, IN in 1960, and Princeton, IN in 1946. Three full-time employees started the Janesville office in 1982, and today we are one of Pioneer's larger research facilities. We have 20 full-time employees on our staff today, with 9 having M.S. or Ph. D degrees. Our part-time workforce varies with the seasonal nature of growing corn, and we do use around 50 high school students in July to help with our field work.

Plant breeders have two roles to play. One is to develop improved hybrids to satisfy demand from domestic users of corn for animal feed, bio-fuels, industrial chemicals, and food corn. World population growth projections require significantly higher agricultural production. A second task is to add yield to existing crop land to compensate for acres lost due to urbanization, development, and infrastructure growth. We all are familiar with the stories that the 4-H fair grounds used to be on the east edge of Janesville. I encourage the MPO to define and clearly state their views on preserving highly productive farm land adjacent to Janesville. Understanding the contribution of agriculture to the local and regional economy must be a part of a solid growth plan for Janesville.

We are aware of planning for the Highway 11/14 project, which certainly has proposed alignments in La Prairie Township. The Highway 11/14 - Milton-Shopiere intersection is a significant safety concern for our staff during the day as we go to and from work. Eastward growth of Janesville, the new alignment of 11/14, and availability of uniform farmland for our research programs all become important long-term considerations for our continued work and success.
