


### I. INTRODUCTION

The Janesville Area Metropolitan Planning Organization's (MPO) 2004 Public Participation Procedures were used to solicit public input for the 2005-2035 Long Range Transportation Plan (LRTP).

Public hearing notices were published in the Janesville Gazette. Documents were made available for review at the Janesville and Milton libraries, the Janesville Community Development Department and on the MPO website.

### II. NOTIFICATION PROCEDURES & DOCUMENT REVIEW

### PUBLIC NOTICE

Public notices were posted in the Janesville Gazette prior to each meeting of the Technical Advisory Committee (TAC) and MPO Policy Board (Policy Board). The notices covered the topics to be discussed, the day, time, and location of the meeting, along with contact information for the MPO. An example is given below.

### **PUBLIC NOTICE**

The City of Janesville will be conducting meeting of the Metropolitan Planning Organization's (MPO) Technical Advisory Committee. The MPO is coordinating committee which reviews highway, transit, and bicycle/pedestrian projects in the City of Janesville, the City of Milton and the towns of Janesville, Harmony, Rock, La Prairie, and Milton. ### **INVITATIONS SENT**

At least a week prior to each TAC meeting, announcements were sent to all 149 individuals and organizations listed on the MPO Public Participation Mailing List. The announcement invited the recipient(s) to attend the meeting, described the issues to be discussed, indicated where the documents were available for review, and how to contact the MPO with questions or comments. A mailing was also sent when the final draft was complete and open for public comment.

The Policy Board meeting to address the TAC's recommended approval of the LRTP was open to the public, and was held on May 10, 2006.

### STOP IN

The public could request documents and speak with staff one-on-one at the MPO office.

### EMAIL & FAX

Comments could be submitted to the mpo by email or FAX and requested documents could be sent to recipients in the same manner.

### IV. COMMENTS RECEIVED

### **GENERAL**

Those wishing to comment on the documents to be reviewed at the TAC or Policy Board meeting could submit them in person at the meeting, or at the MPO office by phone, or in writing (email, FAX,

or letter). When possible, the comments received at the meeting or by phone were addressed in the same conversation, and additional follow-up was provided when needed. When appropriate, the comments received were incorporated into the document.

### **PUBLIC COMMENT**

The public comments received are organized by the element of the LRTP that they pertain to; the majority of comments were received at the TAC meetings.

### General

Prior to each meeting, WisDOT and FHWA reviewed the documents and submitted their comments in writing. Their requests for technical revisions were incorporated into the document and any significant issues were discussed at the meetings.

### Introduction

The comments below were received at the January 18, 2005 TAC meeting.

Ty Bollerud, 424 S. Pearl – Spoke regarding the future availability of school sites on the far northeast side of Janesville.

At the meeting, Brad Cantrell indicated that adjustments have been made for future growth in that area.

Richard Frank, 1119 Elida – Spoke regarding a possible Highway 14 by-pass to connect with the future Highway 26 by-pass.

Comment from the TAC was not needed.

Jack Kislia, 3600 Hickory Dr. – Requested a list of Technical Advisory Committee members and who they represent.

The MPO supplied Mr. Kislia with the requested list.

Donald Boughton, 5211 N. River Road – Inquired about the status of the access road on the eastside of Highway 26 extending to his property.

At the meeting, Brad Cantrell advised Mr. Boughton to attend the upcoming Highway 26 meeting and express his concerns about the issue during the meeting.

Roger Anderson, 4109 W. County Trunk A – Inquired about the status of the Highway 11 bypass extension north from Court Street to Highway 14.

At the meeting, Brad Cantrell indicated that the City has identified this extension on transportation planning maps for the past several years, but stated that the project is only being illustrated as a future improvement at this time.

Ty Bollerud, 424 S. Pearl – Asked for a prioritized list of street projects and repairs.

At the meeting, Brad Cantrell indicated that a list exists in the Transportation Improvement Program, which is available as public record in the Planning Department.

### **Bicycle and Pedestrian**

There was no public comment to record.

### **Transit**

There was no public comment to record.

### **Freight**

The comments below were received at the October 4, 2005 TAC meeting.

John Demes, 638 Burbank Avenue, inquired about previous and future efforts to extend commuter service from the Chicago area to Harvard or Clinton and potentially Janesville.

At the meeting, Brad Cantrell noted that there have been a number of efforts at the state level to determine the feasibility of this service. He also indicated that further efforts from the state are probably required prior to additional involvement from the MPO or the City.

### **Streets and Highways**

The comments below were received at the December 19, 2005 TAC meeting.

Sharon Roberts, 1654 S La Prairie Townhall Road, stated that by showing the bypass on the map in any form implies that the project and the alignment is approved. She indicated that it may be more accurate to put a note at the bottom of the map indicating that the project is under study and the alignment is not determined.

At the meeting there was general discussion on whether or not to show the study areas on the map and then how to depict them on the map with no final decision agreed upon. Dave Mumma stated that the arguments being made were over the semantics of how to show study projects. He stated that by showing the project on the map the MPO is at least defining a potential location and not hiding the information in the text. The final decision was to highlight the area for the potential alignment with a red oval.

alexis,

thanks for the information on the meeting, the information and the meeting was very interesting.

after the discussion at the meeting about project proposal #56, I checked some aerial photos of the area. the corridor north of milton, around hwy 59 and clear lake road is already filling fast. 30

years from now it will be very difficult/impossible to find room for a bypass thru this area. i think the county growth planning has most of this area already eyed for development.

i can see that the same thing will happen here as happened with the hwy 26 by-pass around the east side of milton, 30 years ago there was room, and i think even a plan/corridor marked out to put the by-pass on the near east edge of milton, keeping that area open would have saved huge amounts of time, money and land.

also, i think that if they could have kept the traffic closer to milton, it would have had a positive impact on the east side business.

The project being discussed in the email is a proposed connection between I-39 and HWY 26 North of Milton. At the meeting Mr. Brown attended on December 19<sup>th</sup>, the TAC discussion if the project should be removed from the plan or if it should be a recommended project, but not shown on the map. In response to the comments received at the meeting, the MPO, the City of Janesville, and the City of Milton meet to discuss the project further. They decided that the need for the project was likely, but would most likely occur outside of the plan's scope. Therefore, the project was listed as a project recommended for future consideration. The City of Milton, though in agreement with the need to consider such a project in the future, was concerned that the identification of a potential corridor at such an early date would have a negative impact on future development. The MPO, City of Janesville and City of Milton decided to note the alignment on the map with a caption, instead of illustrating it. The altered map was reviewed by the TAC on January 31, 2006, and approved with the rest of the document.

### **Implementation**

There was no public comment to record.

### **Environmental Justice**

There was no public comment to record.

### 1. Approval of the minutes

After roll call, Tom Rogers indicated that the meeting notes from the last Technical Advisory Meeting on September 23, 2004 had omitted his name as a supporting vote for the amendment to TIP removing item #25.

There was a motion by Todd Schmidt with a second by Dave Mumma to approve the minutes of the September 23, 2004 Technical Advisory Committee meeting with Rogers revision. The minutes were approved unanimously.

### 2. Review of draft Introduction section of the 2005-2035 Long Range Transportation Plan

Brad Cantrell provided a brief overview of the agenda and format for the meeting. MPO Coordinator Michelle Bostinelos described the elements of the draft introduction reviewing its content page by page. Barb Feeney indicated that she would like to see past population figures in order to compare that to future growth projections.

Carolyn Brandeen requested that there be a table in the Appendix showing projections for the various age groups for future years.

Stephanie Hickman questioned where Environmental Justice was going to be addressed within the document.

A discussion ensued between Barb Feeney and Dave Mumma regarding the TDP and how that information will be included within the Long Range Transportation Plan.

Michelle then indicated that following the Public Hearing, the Committee would forward the draft introduction to the Policy Board for their review. Michelle then opened the floor to discussion among Committee members.

Barb Feeney indicated that the State Highway 14 project is not budgeted for construction; it remains a study at this time.

Dave Meurett noted that the list of objectives should include references to freight and economic development, as well as inter-governmental coordination between the MPO jurisdictions.

Todd Schmidt, Milton City Administrator, recommended the following changes:

- In the plan overview section (pg. 1), change "Janesville's transportation planning process," to "Janesville Area MPO transportation planning process"
- Whether any of the towns had plans that should be added to the Long Range Transportation Plan section (pg. 3)
- Noted that Milton would begin updating their comprehensive plan in February, 2005
- Noted that Milton's city limits has changed from that on Figure I-1 (pg. 7)

- Asked if copies of the draft plan could be made available at the Milton Public Library as well as the Janesville's Hedberg Public Library.
- In the Access Management Site Plan Review section (pg.15) indicated that Milton does not have a Planning Department and the term should be more generalized to "Planning Staff" or "City Staff"
- Milton has some additional items that should be listed under the Critical Area Plans section (pg. 15)
- Milton has some additional items that should be listed under the Downtown Redevelopment section (pg. 16)

Ben Coopman, Rock County Highway Commissioner, suggested that there should be a Plan objective which considers jurisdictional responsibilities and functional classifications of the roadway systems. This could be included in the Highway section of the Plan.

### 3. Public Hearing on draft Introduction section of the 2005-2035 Long Range Transportation Plan.

Brad Cantrell opened the Public Hearing for review of the Introduction section.

Brad Cantrell provided the Committee with the upcoming meetings in April regarding the Bike and Pedestrian portions of the Long Range Plan, and the Policy Boards meeting to approve the draft introduction section.

Brad Cantrell provided a brief overview of the agenda and meeting format. Matt Anderson presented the draft version of the Bicycle and Pedestrian element. He reviewed the Plans goal, objectives, the phasing and funding of projects, along with other elements.

Mike Hayek questioned if there was sufficient width along Wright Rd and Kellogg to allow for on-street bike lanes.

Matt Anderson indicated that each section seems to have enough room for dedicated bike lanes.

Dave Mumma inquired if the placement of on-street bike lanes would conflict with transit, especially along the curb lanes.

Tom Huber felt that on-street bike lanes and shared bus / bike lanes would not cause any operational issues for buses.

Mike Hayek said that the Wright Road on-street bike lanes should be added at the time it is extended. He asked if lanes should also be added to East Rotamer Rd as improvements are made to it. Staff agreed that they should.

Todd Schmidt suggested adding a bike trail extension to the SW portion of Milton, along the abandoned rail road corridor.

Stephanie Hickman questioned how the proposed trial improvements will address environmental justice.

Brad Cantrell said that the downtown is the hub for the Janesville trail system, which is where the largest portion of the target population is located.

Tom Huber suggested that a recommendation be added for buses to have bike racks.

Brad Cantrell indicated that the Highway 26 Trail north of Townline Road should follow the current Highway 26 corridor through Milton and continue North to the Jefferson County line. He also recommend that both Highway 26 routes be included in the Plan.

Barb Feeny mentioned that cost sharing may be required to add an off-road trail to the 26 Bypass Plan.

Todd Schmidt indicated that due to the way the Highway 26 Trail is shown, the Plan should mention that there will be connectors to Milton's commercial area from the Industrial Park on the eastern side, and that there should be a link to a large park on the south side of Milton.

Phil Blazkowski indicated that Madison Street could be a location for an on-street bike route. He also pointed out that the on-street bike routes on Milton should be reflected in this part of the Plan.

It was decided that Matt Anderson and Todd Schmidt will collaborate and share information on Milton's routes and how they will be reflected in the Plan.

Dave Meurett indicated that the high number of crashes along Centerway may be indicative of the need for a dedicated bike lane there. He also indicated the potential need for a safety study at the intersection of Rockport and Center Ave, the intersection with the highest number of incidents.

Carolyn Brandeen indicated that a copy of the Rock County Bike Trail Plan was needed to aid collaboration between all entities involved.

Phil Blazkowski mentioned looking into rails to trails for the Beloit – Janesville Corridor.

Stephanie Hickman said that a statement was needed indicating the collaborative efforts between JATS and SLATS.

Tom Huber indicated that the mention of education and enforcement needed to be incorporated into the objectives.

Carolyn Brandeen said that she would like to see the Bike and Pedestrian section displayed more prominently in the MPO section of the City of Janesville's website.

Brad Cantrell said that at the next TAC meeting the Bicycle and Pedestrian element of the Long Range Transportation Plan would be considered for adoption with all changes to the section applied as discussed, along with any amendments.

### 3. Public Hearing and comment session on draft Bicycle & Pedestrian Element of the <u>2005-2035</u> Long Range Transportation Plan.

There was no public comment to record.

### 4. Review of an amendment to the 2005-2010 Transportation Improvement Program.

Duane Cherek provided an overview of the proposed TIP amendment. It was requested that funds be transferred from the Ruger Ave project to the East Rotamer Road and Court Street projects, delaying the improvements to Ruger Ave.

Stephanie Hickman requested that staff verify if this was a preservation project and if it was shown in the Long Range Plan.

Todd Schmidt motioned to approve as recommended. Phil Blazkowski seconded the motion to forward the 2005-2010 TIP amendment to the MPO Policy Board. The recommendation was unanimously approved.

### 5. Review and Discussion of Preliminary Traffic Projections from the Transportation Model

Kurt Miller from WisDOT provided an explanation of the transportation modeling process and status of that activity for the JVL MPO. All committed transportation improvement projects, those identified in the JVL MPO TIP and the State TIP for this area, are included in the model.

Kurt indicated WisDOT staff will be working with the JVL MPO to identify any additional planned projects. The model will then incorporate those projects and identify potential future deficiencies.

The Planning Department asked for a list of the committed projects included in the model.

Kurt indicated that the model can be further discussed at a future meeting of the JVL MPO.

Meeting adjourned at 4:50 p.m. on June 18, 2005.

### 1. Approval of the June 14, 2005 minutes.

It was noted that the Milton Township representative is now Bryan Meyer, replacing Harold Traynor.

Dave Mumma moved to approve the meeting notes from the June 14, 2005 Technical Advisory Committee Meeting (TAC) and Todd Schmidt seconded the motion. The motion was unanimously approved.

### 2. 2006 – 2011 Transportation Improvement Program

Alexis Kuklenski provided a brief overview of the draft 2006-2011 Transportation Improvement Program.

Stephanie Hickman asked if the MPO would be including the Project Prioritization process in the TIP. Duane Cherek indicated that while MPO staff was aware that establishing a TIP project prioritization process must be provided; this effort was delayed in order to complete a variety of tasks. Brad Cantrell responded that due to recent additions of new staff members to the MPO and the City of Janesville this process has been delayed in order to allow input from the new staff members. This issue will be addressed at future Policy Board and TAC meetings.

There was general discussion about the timing of construction phases and specific projects by the committee. A major item of discussion was the inclusion of language pertaining to Hwy 26 in the policy board resolution to adopt the TIP. Todd Schmidt indicated that this stipulation is a major issue for the City of Milton and the City of Janesville and it should remain in the resolution. Dave Meurett stated that the stipulation for Hwy 26 was in the previous TIP and that WisDOT approved the resolution without recognizing the stipulation and that this would most likely occur if the language remains with the current TIP.

Stephanie Hickman requested that maintenance and operational costs be identified in the TIP separate from project costs. Brad Cantrell stated that these are already delineated as separate in the local operating budgets for Janesville and Milton as a required accounting procedure.

Dave Mumma moved to approve TIP, as amended, and forward it to the Policy Board with a favorable recommendation. The motion was seconded by Jack Messer. The motion was unanimously approved.

### 3. 2006 Work Program

Alexis Kuklenski presented the 2006 MPO Work Program.

Dave Murett noted that MPO staff, WisDOT, and FHWA would be reviewing the allocation amounts indicated in the Work Program on Wednesday October 5. The total dollar amount in the program would not change as a result of the meeting, however the percent allocated to specific project would be examined.

The project selection process for the TIP STP – Urban Fund projects will be added to the work program.

Ben Coopman stated that there is a need, from the county perspective, to establish jurisdictional responsibility for roads throughout the county and possibly addressing this as part of a functional classification study. Stephanie Hickman stated that this could be done with discretionary funding, and this effort could assist in the development of the next update to the Long Range Transportation Plan.

Todd Schmidt moved to approve Work Program and provide the MPO staff with the authority to make adjustments to the allocation amounts as necessary. The motion was seconded by Jack Messer and unanimously approved.

### 4. Review of revisions to the Bicycle & Pedestrian Element of the 2005-2035 Long Range Transportation Plan

Matt Anderson presented the update of the Bicycle and Pedestrian Element of the Long Range Plan. The update included changes based on the recommendations received at the June 14 TAC meeting.

Todd Schmidt requested that a bike lane be recommended for Town Line Road in Milton from the new Hwy 26 overpass area in Milton west to the future Milton-Janesville Trail.

Todd Schmidt moved to approve the Bicycle & Pedestrian Element and forward it to the Policy Board for final approval and Dave Mumma seconded the motion, which was unanimously approved.

### 5. Public Hearing and comment session on draft Freight Element of the 2005-2035 Long Range Transportation Plan

Alexis Kuklenski presented a draft of the Freight Element of the Long Range Transportation Plan for review and comment from the committee.

Dave Murett indicated that WisDOT would like to reevaluate the data that was provided to the MPO regarding the volume of shipping and the origin of various types of shipments.

Todd Schmidt requested that the spur line leading to the Milton east side industrial park be added to the rail map in the plan.

Dave Mumma noted that the ownership of the rail lines should be verified due to recent transactions between different railroad companies.

Duane Cherek provided a summary of the proposed highway projects examined through the traffic modeling process for the Highway Element of the Long Range Transportation Plan. A general discussion regarding these projects and the initial model results ensued.

Stephanie Hickman noted that a fiscal analysis of these projects will be required as part of the plan and that some projects that do not have identified funding sources or budgeted dollars may be included as illustrative projects.

### 3. Approval of the minutes from the October 4, 2005 Technical Advisory Committee Meeting.

On the motion by Jack Messer, seconded by Dennis Ryan, the October 4, 2005 MPO meeting minutes were unanimously approved as presented.

Ben Coopman noted that John Lader may no longer be the representative for LaPrairie Township.

### 4. Review of revisions to the Freight Element of the 2005-2035 Long Range Transportation Plan.

Brad Cantrell summarized the revisions made to the Freight section since the last meeting.

Stephanie Hickman asked if her most recent suggestions had been incorporated into the document.

Alexis Kuklenski indicated that they had.

On the motion of Jack Messer, seconded by Mike Hayek, the TAC unanimously approved recommending the Freight section of the 2005-2035 Long Range Transportation Plan to the Policy Board.

### 5. Public Hearing and comment session on draft Transit Element of the 2005-2035 Long Range Transportation Plan.

Matt Anderson, Associate Planner, summarized the key points of the 2005-2035 Long Range Transportation Plan's Transit section.

Kurt Miller indicated that a study of commuter rail from Harvard, IL to Wisconsin has been approved and this should be referenced in the plan.

Stephanie Hickman asked if her comments had been incorporated into the plan.

Matt Anderson said that they had not been yet, but would be.

Ben Coopman asked if the Janesville Transit System (JTS) would offer fixed route bus service to Milton.

Matt Anderson said that the plan indicates this potential need would be evaluated in future TDP studies. One way that Milton could be served is to run a local circulator route within Milton and a direct route between Milton and Janesville along CTH Y or HWY 26.

There was a general discussion on the service density needed to serve transit.

Matt Anderson indicated that the densities are currently being developed by the consultant in charge of the TDP.

Stephanie Hickman indicated that service densities may help in determining which areas can support service and those that can not. That information would be helpful in environmental justice analysis.

Brad Cantrell asked the TAC what they would like to do in regards to moving along the transit section. He indicated that they could review a second draft at the next meeting or approve it as it is with the changes suggested by the TAC.

Kurt Miller indicated that approving the document with the changes discussed would be fine.

On the motion of Jack Messer, seconded by Dennis Ryan, the TAC unanimously approved the Transit section of the 2005-2035 Long Range Transportation Plan with the changes discussed.

### 6. Public Hearing and comment session on projects being considered for modeling as part of WisDOT's transportation demand model.

Alexis Kuklenski presented the projects being included in the transportation demand model developed by WisDOT for the Janesville Area MPO.

Kurt Miller explained the rational for modeling and the results of the model. He also shared the results of further modeling being done by WisDOT to evaluate the impact of the MPO's projects on the region. Kurt indicated that the extension of Highway 11, from the bypass north to Highway 14, would carry approximately 9,300 trips in 2035 but it would not alleviate congestion on I-90. In addition, the model currently shows that the trips carried on the extended bypass would primarily be local trips, (only 1,300 trips would be along the entire length of the bypass) indicating that there may not be a justification for state funding.

There was general discussion among the TAC about the validity of the model's results. Staff from

Janesville stated that they felt that the bypass would become a viable alternative travel corridor to I-39 as congestion along that route increases in the future.

Brad Cantrell indicated that he would like to see the socioeconomic data used for the balance of Rock County as it applies to the model.

Jack Messer requested clarification on the origin and destination (O & D) study used for the model.

Kurt Miller stated that the O&D study was done in 2003 for Rock County and the samples were taken along the county's boarder.

Brad Cantrell was concerned that the O&D study done for Rock County may not be able to accurately reflect certain inter-county trips, such as those between Janesville and Evansville. He stated that a O&D study was done for the MPO around 1998 and that it may be worth looking at the percentage of through trips in 98 compared to 03.

Barb Feeney stated that the bypass doesn't need to be justified in the plan, it only needs to be listed as under study.

Brad Cantrell said that this project has been in the works for numerous years and was a very important project to the Janesville Area and therefore to the plan.

Barb Feeney said that the environmental process must be followed. Including the project in the Plan is the MPO's choice but it suggests to the public that it is an approved project.

Brad Cantrell indicated that the purpose of the long range transportation plan is to identify future traffic volumes and improvements needed over the next 30 years. The public participation process is very important. Because of public participation, the scope and alignment of projects may change. However, the need is there, that is what we are identifying.

Barb Feeney stated that they were questioning the need and would like the plan to specify the project is under study.

Stephanie Hickman said that federal regulations reference that the need for a project has to be established. She said that the traffic modeling results that WisDOT had been presenting do not currently support that there is a need for the bypass. No deficiencies identified, as an example those on I-39, are alleviated. She said that a without alleviating deficiencies it is difficult to say that there is a demonstrated need.

Dennis Ryan asked what is being done to address the deficiencies projected for I-39 in 2035 at six lanes. He said those deficiencies are the reason this is being included.

Kurt Miller said that the extension of the Highway 11 bypass did not address the congestion along I-39.

Jack Messer questioned weather or not there was an invalid assumption in the model because something has to happen on I-39 when you provide alternate routes.

Ben Coopman said that the question was one of the chicken or the egg. This is a plan so it is difficult to say what you do first, wait for the problem and address it, or plan for the potential problem.

Stephanie Hickman said the demand should be documented which may address congestion, continuity, or regional need. One such measure of technical analysis is provided by the deficiency model.

Brad Cantrell said that an O & D survey closer to Janesville (rather than County Lines) would more accurately reflect the through trips that occurred and that is why it is important to compare the 98 O&D survey to the one from 2003 that was used in the model.

Jack Messer pointed out that there is a difference between modeling, proving and reality.

Kurt Miller replied by saying that that was the reason for the model.

Jack Messer pointed out that the model is only as good as what you put in. And said that it is important to look at all the available information, and not use one tool that has the potential to be flowed.

Barb Feeney said that the model is calibrated to actual traffic counts and best guesses. She then related a story about projects she was working on in Madison in which the model was giving unexpected results.

Brad Cantrell said that he would like to look at the model in more detail. He said that the model results appear to be inaccurate, and stated that it is his responsibility to question the data and get to the point where he feels comfortable with the assumptions made.

Barb Feeney said that if the bypass were built then Highway 14, through Janesville, would probably be converted to the jurisdiction of the City of Janesville.

Dennis Ryan questioned the model's assumption that a majority of through trips coming from the west would travel along highway 14. He went on to state that even if Highway 14 was 6 lanes there would still be 10 or 12 lights, limiting the number of vehicles that could pass through a light during a cycle and extending the time it would take for traffic to get around the city.

Kurt Miller replied that the model is not a calibration model, it is a planning model so it does not account for the number of lights. It applies an average speed for a trip between A and B.

Brad Cantrell stated that traffic wanting to get through or around Janesville, but wanting to avoid the interstate would not take highway 14, they would take the bypass. This route would provide the least traffic and impedances, and therefore it would provide the fastest trip.

Brad Cantrell went on to ask if there were any other concerns.

None were voiced.

Brad Cantrell stated that he appreciated the opinions, views expressed, and felt good about the discussion. He said he understood that Stephanie felt that the modeling results did not demonstrate that the project was needed, but reiterated that he felt the project was needed and will be justified. He said that the City would need to work with WisDOT to ensure that the data imputed was accurate.

### 7. Matters not on the agenda.

Dave Mumma, who arrived after the Transit section had been reviewed, asked if there were any points he could clarify.

Ben Coopman asked about the status of the TDP.

Dave Mumma indicated that the TDP was on hold due to staff constraints, and is expected to be

approved in early spring of 2006.

### 1. Approval of the minutes from the November 30, 2005 Technical Advisory Committee Meeting.

Stephanie Hickman noted two changes which were submitted by email to Alexis Kuklenski prior to the meeting. On the motion by Dave Muma, seconded by Dennis Ryan, the November 30, 2005 MPO meeting minutes were unanimously approved with amendments.

### 2. Review of revisions to the draft Streets & Highway Element of the 2005-2035 Long Range Transportation Plan.

Alexis Kuklenski, Associate Planner, summarized the key points of the 2005-2035 Long Range Transportation Plan's Streets & Highways section.

Brad Cantrell indicated that the DOT had submitted a number of comments in writing which will be examined and incorporated into the next draft, before it is distributed to the TAC for the next meeting.

Mike Saunders indicated that La Prairie Township will have a public meeting in January to review the proposed HWY 11/14 bypass extension located in the vicinity of Avalon Road and County Highway J. Saunders stated that the town is focused on maintaining and conserving agricultural land and wants to be proactive concerning the location of the bypass. Comments received at the town meeting will be provided to the MPO and the TAC.

Ben Coopman noted that it is important for the town board and the residents of the town to attend the DOT public comment meetings regarding the bypass and the future alignment.

Brad Cantrell reiterated that the exact alignment for the southeastern bypass is not known and that the recommendation is to study the necessity for the bypass.

Brad Cantrell then opened the public meeting.

Sharon Roberts, 1654 S La Prairie Townhall Road, stated that by showing the bypass on the map in any form implies that the project and the alignment is approved. She indicated that it may be more accurate to put a note at the bottom of the map indicating that the project is under study and the alignment is not determined.

There was general discussion on whether or not to show the study areas on the map and then how to depict them on the map with no final decision agreed upon. Dave Mumma stated that the argument is over semantics on how to show study projects. He stated that by showing the project on the map the MPO is at least defining a potential location and is not hiding the information in the text.

Ron Brown, 2626 County Road M, asked what the different project colors on the map indicated.

Alexis Kuklenski explained that red identifies committed project (those listed in the 2006-2011 TIP) and purple identifies planned projects (those not listed in the TIP). Brad Cantrell then provided a brief explanation of how projects and their timing are identified and that the plan is updated every five years in order to better identify funding sources and when projects should occur.

Todd Schmidt indicated that from Milton's perspective, showing project #57 on the map, the northern bypass around Milton, is premature at this time, and that Milton and Janesville should have further discussions about this project prior the completion of the second draft of the Streets and Highways section. There was general discussion about this project with Barbara Feeney noting that the model does not indicate a need for this project. This led to additional discussion about the modeling results and the need to conduct studies for potential long term projects based on factors in addition to the model results. Barb Feeney stated that it may be more appropriate to include this project on the next plan, which will be done in five years.

Upon conclusion of this discussion there were no additional comments. MPO staff will integrate comments received in writing and those from the meeting into a second draft of the Streets and Highways Element of the 2005-2035 Long Range Transportation Plan. That draft will be distributed to the TAC prior to the next meeting in mid January. The TAC will vote on approval of the element at that time.

### 3. Public Hearing and comment session on draft Implementation Element of the 2005-2035 Long Range Transportation Plan.

Alexis Kuklenski, Associate Planner, summarized the key points of the 2005-2035 Long Range Transportation Plan's Implementation section.

Dave Meurett stated that the DOT has reviewed the section and will submit comments in writing to the MPO

Brad Cantrell indicated that the TAC will need to vote on this section and forward it to the Policy Board at the next TAC meeting

### 4. Matters not on the agenda.

There were no matters for discussion.

### 5. Adjournment.

3. Approval of the minutes from the December 19, 2005 Technical Advisory Committee Meeting.

On the motion by Todd Schmidt, seconded by Michel Hayek, the December 19, 2005 MPO meeting minutes were unanimously approved as presented.

4. Review of revisions to the draft Streets & Highway Element of the 2005-2035 Long Range Transportation Plan.

Alexis Kuklenski, Janesville Area MPO Coordinator, summarized the key points of the 2005-2035 Long Range Transportation Plan's Streets & Highways Element and the revisions that had been made to the second draft.

Mike Saunders asked for clarification on how the underpass shown along I-90 in Figure 4 was consistent with the Town's goal of farmland preservation.

Brad Cantrell indicated that future growth would likely require a east-west connection across the southern half of the interstate, and that growth would drive the final creation and placement of the underpass.

Discussion followed regarding the best language to use to describe the potential underpass. The committee agreed that there was the potential need for an east-west connection at some point in the future, and that the specific type

of connection is not known at this time. The TAC decided that the potential connection should be described as "East-West Grade Separation Under Study."

Stephanie Hickman suggested additional language changes be made to Figure 4. She requested that the caption for projects 51, 57 & 59 (North Side Bypass) begin with the phrase "Proposed Concept Study," and that the caption for project 55 be changed to "Concept Under Study."

Barb Feeney called attention to Table IV-30, and stated that many of the projects weren't planned, they were just recommendations so the table should not be titled Planned Projects. In addition, she felt that the expansion projects recommended for study should be listed separately to eliminate any confusion regarding their status.

Stephanie Hickman suggested changing the table's title to "Recommended Expansion & Study Projects," which the TAC agreed with.

Mike Saunders drew the committee's attention to the Implementation Element, and suggested that the following language be added to the end of the 15th bullet point on page VII-9, "while working with other jurisdictions to preserve agricultural lands."

Discussion followed on the appropriateness of considering the value of just agricultural lands vs. some of the other potential needs. The discussion resulted in the TAC agreeing to two changes.

- 1. The last bullet listed under policies and planning objectives for factor 1 (on page VII-5) would be changed to, "Coordinate with appropriate jurisdictions through the MPO planning process."
- The 15<sup>th</sup> bullet on page VII-9 would be changed to read, "Construct new roads or reconstruct existing roads to meet demands of high growth areas on the urban fringe, in consultation with adjourning jurisdictions and the County".

Phill Blazkowski stated that the commuter rail extension, from Harvard IL, to Rock County should be included as a recommended study in the Long Range Transportation Plan (LRTP).

Alexis Kuklenski stated that it had been addressed in the Transit Element of the LRTP.

Brad Cantrell explained that the MPO is currently involved in the study and has it listed as an activity within the work program. It was his understanding that the Beloit MPO wanted to take the lead on the project, and that the Janesville Area MPO would be working with them.

Stephanie Hickman indicated that spending for Operations and Maintenance (O & M) needs to be listed as a separate line item before the final approval by the MPO Policy Board.

Alexis Kuklenski then summarized the suggested changes that had been made, and requested that the document be forwarded to the Policy Board with the changes discussed.

Brad Cantrell then opened the public hearing.

Gordon Hill of LaPrairie Township (a former County Chair), indicated that the changes suggested were appropriate.

Jack Messer moved to forward the document as amended to the Policy Board, and the motion was seconded by Phil Blazkowski, with unanimous agreement from the TAC.

**5.** Public Hearing and comment session on draft Implementation Element of the 2005-2035 Long Range *Transportation Plan*.

Brad Cantrell opened the discussion.

Barb Feeney requested that the safety study referenced in the Streets and Highways Element be included as a Planning Activity under the 2<sup>nd</sup> TEA-21 Planning Factor (pg VII-6)

Kurt Miller suggested that each factor correspond to the objectives by referencing which elements address each *Janesville Area Long Range Transportation Plan* 

factor.

Stephanie Hickman stated that operation and maintenance costs associated with streets and highways need to be listed as a separate line item.

Brad Cantrell opened the public hearing. There was no comment.

Jack Messer presented a motion to forward the document as amended to the Policy Board and the motion was seconded by Mike Saunders, with unanimous agreement from the TAC.

**6.** Public Hearing and comment session on draft Environmental Justice Element of the 2005-2035 Long Range Transportation Plan.

Alexis Kuklenski gave an overview of the element's key points and findings.

Stephanie Hickman asked how 68% was derived as a significant measurement.

Alexis Kuklenski replied that it involved the use of one standard deviation around the mean to arrive at the measurement.

Kurt Miller requested that the location of the recommended on street bike routes be referenced in the EJ Element.

Stephanie Hickman requested that a discussion on the densities needed to serve transit be provided somewhere in the plan.

Alexis Kuklenski replied that it is addressed in the Transit Element.

Jack Messer presented a motion to forward the document as amended to the Policy Board and the motion was seconded by Phil Blazkowski, with unanimous agreement from the TAC.

### **7.** Matters not on the agenda.

Brad Cantrell indicated that the next step was to incorporate the changes as recommended by the TAC, and make the document open to public review for the required 45 days. The final document will then go to the Policy Board for their approval.

There were no other matters for discussion.

### 7. Review and Approval of 2005-2035 Janesville Area Long Range Transportation Plan..

Alexis Kuklenski, MPO Coordinator, presented the *2005-2035 Janesville Area Long Range Transportation Plan* by summarizing each chapter of the plan. After each section, board members were given the opportunity to provide comments and ask questions.

Transit Element – no discussion

**Bicycle and Pedestrian Element** – Steve Sheiffer, Janesville City Manager, asked if the bridge over Highway 26 at E. Rotamer Road was included in the plan. Matt Anderson, Associate Planner, indicated that it was. John Vesperman, WisDOT, was asked if any funding had been identified for the project and he stated that Federal dollars had been assigned to the project in association with the Highway 26 project. Tom Rogers, Janesville Assistant City Manager, indicated that there would also be an opportunity for an overpass at Town Hall Road with the construction of a new interchange at that location.

Streets and Highways – Steve Sheiffer asked if the widening of Highway 14 to 6 lanes was

studied. Alexis Kuklenski indicated that is was and was identified as projects number 57, 46 and 45. Kuklenski also noted that the recommendation in the report was to conduct a study on the necessity and feasibility of six lanes and the impact to the transportation network. Steve Sheiffer asked if the Highway 26 – McCormick Road intersection versus overpass question had been resolved. John Vesperman indicated that it has and that it will be designed as an at grade intersection and will be constructed with the Highway 26 project. There was mention of the installation of a roundabout at that location and addition discussion of roundabouts followed.

**Freight Element** – Tom Brien, Janesville City Council, asked if there had been any discussion or proposal to expand the freight yards because there are currently a number of traffic delays from trains switching tracks outside of the freight yards and blocking traffic. This has direct impact on GM as workers are often delayed and therefore work at the plant is delayed. Brad Cantrell, Janesville Community Development Director, stated that there have not been any discussions on expansion of the freight yards but Wisconsin Southern is interested in upgrading their rail crossing.

### Environmental Justice Element – no discussion

Janesville City Manager Steve Sheiffer made a motion to approve the 2005-2035 Janesville Area Long Range Transportation Plan. The motion was seconded by Chairman Tom Wellnitz. The motion passed unanimously.
