

1. INTRODUCTION

The Janesville Area Metropolitan Planning Organization's (MPO) followed 2012 Public Participation Plan (PPP) to solicit public input for the 2015-2050 Long Range Transportation Plan (LRTP). The procedures set minimum standards for types of notice, comment periods, and documentation of public participation but the policy document encourages additional methods of public outreach. This appendix documents all outreach related to the development of the LRTP, including open houses, presentations to community groups and tabling opportunities that go beyond the requirements of the PPP.

Public hearing notices were published in the Janesville Gazette. Documents were made available for review at the Janesville and Milton libraries, the Janesville Planning Services Division and on the City of Janesville website on a dedicated MPO webpage.

INTEGRATION OF COMMENTS INTO THE PLAN

Comments from the public were essential to the development of the Plan. The four public open houses hosted at the Milton and Hedberg Libraries were well-attended and provided staff valuable feedback about issues, priorities, and specific projects. Here is a brief summary of the changes made to the Plan based on public feedback:

Freight

Added issue of train noise

Transit

- Clarified any opportunity for service expansion should prioritize Saturday evening and Sunday service, which were not well defined in a previous draft
- Strengthened and expanded language regarding upgrading technology to enhance customer service

Bicycle/Pedestrian

- Prioritized projects based on public feedback
- The public identified several new trail connections during public open houses. Evaluation of the connections is documented in the Plan
- Added language about accessible technology along trail for visually impaired persons

Street/Highway

• Strengthened language prioritizing preservation of the existing system over construction of new highways or capacity expansion

2. NOTIFICATION PROCEDURES & DOCUMENT REVIEW

PUBLIC NOTICE

All public meetings are listed in the City of Janesville weekly meeting notice. This notice is posted at City Hall and submitted to the County Clerk's office and Janesville Gazette. Janesville emails a weekly press release that lists all public meetings. The weekly press release goes to all media outlets in Rock County and anyone who has requested to be on the distribution list.

Class 1 public notices were printed in the Janesville Gazette at least one week prior to each meeting of the Technical Advisory Committee (TAC) and MPO Policy Board (Policy Board) and each public open house. The notices covered the topics to be discussed, the day, time, and location of the meeting, along with contact information for the MPO. An example is given below.

Public Notice

A Public Open House for the Bicycle Pedestrian Section of the <u>2015-2050 Janesville Area Long Range Transportation Plan</u> will be held in the Program Room (upstairs) of Hedberg Public Library on August 20th from 5:00pm to 7:00pm.

Attendees will be invited to view maps of existing plans, share thoughts regarding how to make the Janesville/Milton area a better place for biking and walking, and participate in a brief fiscal prioritization exercise to provide feedback on what types of improvements should be a priority for funding. This open house serves as an early public outreach session to gather information and concerns from residents.

The <u>2015 - 2050 Janesville Area Long Range Transportation Plan</u> will evaluate existing transportation conditions in the Janesville area and recommend improvements for all transportation modes. The Bicycle/Pedestrian section will include goals & objectives of the plan, identify issues and needs, and recommend projects and programs to improve bicycling and walking in the Janesville/Milton area. The 2015-2050 Plan is expected to be adopted in May, 2016.

Other comments/suggestions/questions

- Biggest concern voiced by every attendee is the 1 mile gap in trail between HWY 26 overpass and Glacial River Trail (project #13). Attendees made multiple suggestions, such as one wide shoulder on John Paul Rd that could accommodate two way traffic, a boardwalk over the ditch, and using the state owned WSOR right-of-way just north of John Paul Rd. to build a short segment of trail.
- Multiple attendees voiced concern with traffic on John Paul Road.
- Multiple attendees voiced a need for signage along John Paul Road and other side streets to direct cyclists.
- Other traffic concerns voiced include the intersection of CTH Y and Townline Road and West Rotamer Road.

- A connection to the YMCA would be desirable.
- In the past, a landowner opposed to Project #10 kept the project from going forward but the landowner is now deceased.
- Projects 7 & 8 were discussed by multiple attendees as a solution to the project #13 conundrum of having no easy way to connect the HWY 26 overpass with the trail. One attendee suggested a temporary mowed path.

Open House Public Input on Public Bus Service, October 14, 2015

Janesville Transfer Center

JTS provided an opportunity for transit users to provide comments on improving and better serving the community at the Transfer Center.

Comments:

• An area of concern was is the reduction of level of service on the JMW to exclude a route to Whitewater and the UW campus, and Milton reserving m few

An anonymous transit user stated the JMW re-route would have a major impact in providing a reliable source of transportation to Freedom Graphics in Milton. The individual has been working in Milton and Freedom Graphics for years; but now is reconsidering the added effort, and commitment needed to get to the worksite.

• Another comment included they would like additional service to Beloit on Saturday.

Business Expo, October 15, 2015

Janesville, Holiday Inn Express Convention Center Businesses from Janesville and surrounding cities, and community members

The Business Expo provides an outlet for local and neighboring businesses owners/representatives to showcase their services and products to potential customers/clients. The opportunity provided the MPO to interact with businesses attending the event on how public transit may support and improve their business or how they personally feel about public transit in Janesville.

Business responses

The general response from business owners/representatives was public transportation was not a priority. Responses received varied from:

- Business is located in Downtown or Milton Avenue Commercial area where JTS services already serve
- Business model focus on telecommunication or telecommuting, and does not require public transportation due to the characteristics of that industry
- Employees all have and use vehicles to get to the worksite
- JTS is great

The majority of respondents was small businesses, and did not provide much input on the impact of increased public transit level of service to their businesses.

A Beloit business owner expressed their appreciation for the Beloit-Janesville-Express service route. About half of their workforce is from the Janesville area, however, they did not indicate if any of the workforces uses the BJE.

Sterling Manufacturing (a SE company) stated, "employees don't use the bus because shifts start at 5:30AM", suggesting that there is a potential of their employees utilizing public transit if the level of service met their needs.

An outside business representative was intrigued with the City's outreach to businesses for better public transit.

Lamaar representative suggested that JTS has to do a better job of promoting public transit with branding, marketing and advertisements. Also suggested:

- "Let's Ride the Bus Day" a free day to ride and get accustomed with the JTS system.
- Have a school trip that takes children on the bus to introduce them to public transit.
- "JTS Scavenger Hunt" a scavenger hunt utilizing the JTS buses to complete the game and get people familiar with the bus system.

Personal responses

While businesses did not provide much input on public transit level of services, a higher percentage provided personal comments. Respondents provide these examples of how the JTS can improve on their service levels or routes:

- JMW is great, but disappointed in the 2016 route change to go only as far as Milton, ending public transit connecting Janesville to Whitewater. Daughter uses the bus service to return home for the weekend, but only until end of this year.
- Great that there are services from Janesville to Beloit (BJE), and Janesville to Milton and Whitewater (JMW).
- Some individuals did not know all routes go to the transfer center.
- One person was interested in having routes connecting neighborhoods between Mt. Zion Ave to Milton Ave service route and E. Milwaukee Service routes.
- There is interest with extending Milton Ave routes further north along Highway 26 to the residential areas. This
 provides transportation to churches that provide shelter for the GIFTS homeless shelter that rotates around the
 City.
- One individual questioned about the City's lack of public k-12 school buses.
- Bus service (E.Milwaukee Route) extend route on Wright Rd north to Wright Rd and Sandhill Dr.
- W. Court St Route serves Blackhawk well.

Overall, individuals felt that the service is great with very good coverage. Most comments were to extend services out a little further into residential areas and outside edge of the City.

Rock Trail Coalition Meeting December 3, 2015

MPO staff was invited to the Rock Trail Coalition Business meeting to give a presentation on the Bicycle & Pedestrian Plan and short-term projects. Approximately 30-35 individuals attended. Here is the summary of comments from the meeting:

- Ice Age Trail crossing at Centerway (USH 51) is very hazardous.
- Multiple individuals expressed support of City's recently submitted grant application to fill the gap between the STH 26 overpass and the Glacial River Trail.
- Individuals asked clarifying questions about safety conversions.

Public Open House March 15, 2016

Approximately 15 individuals attended. Here is the summary of comments from the meeting:

- One resident supports bus service to SE area of Janesville. Also wonders if Saturday BJE service or Sunday service will be implemented. Nolan replied financial resources will determine future service expansions.
- One resident asked about installation of audible walk signals. Janesville installs retrofits roughly one intersection per year, or as part of a major road project.
- One resident encouraged inclusion of technology along trail that is accessible to visually impaired.
- One resident questioned the timeline and feasibility of the North Side Bypass. Nolan replied it is recommended for study, but no planning has been conducted to date. Resident expressed concern the project would dramatically alter the rural landscape north of Milton.

Public Open House March 16, 2016

Approximately 13 individuals attended. Here is a summary of comments from the meeting:

- Several area residents were concerned with a new rail line being proposed by Great Lakes Basin Railroad. The
 rail line is intended to bypass congestion in the Chicago area and residents had heard the alignment is planned
 to be east of Milton. The proposed rail line is outside of the MPO planning boundary, and Terry Nolan
 explained that the MPO has no involvement with the project.
- One resident asked about the timeline for the North Side Bypass because she lives in the area. Nolan explained it was included in the 2005 Plan as recommended for study but nothing has been studied to date.
- Residents agreed Townline Road is used as a cut through and traffic has increased.
- Town Hall Rd. is busy and narrow for cyclists.
- A trail connection exists to Milton via Townline. A direct connection to Henke may be a low priority.
- Support future extension of Hilltop to Townline Road.
- Disagreement with road diet on E. Milwaukee Street.
- Multiple residents agreed Milton needs a grade separated rail crossing.
- Concern for lack of trail connection from Glacial River Trail to Janesville. Nolan explained the planned improvement and the grant request that was recently submitted.

- Parking Plaza used as bridge. Should maintain connection when Plaza is removed.
- Need a Newville to Milton connection. Milton could benefit from people staying at campgrounds biking into Milton.
- Crossing HWY 14 in the rural area west of HWY 14 lacks a good North-South connection. Cyclists use Eagle Road to cross HWY 14.
- Pedestrian button at Kennedy/Randolph.
- Ruger Ave/HWY 14 crossing is dangerous.
- Delavan Drive to Prairie Town Hall Road used as south exit out of Janesville.
- Crosby Bridge over Rock River is ok.
- Trail crossing at Centerway on the west side of riverwalk in downtown is dangerous.

- On road connection from HWY 26 overpass to trail John Paul Rd- is not comfortable because of narrow shoulders and high speed.

2. Recommend off street improvements

Terry summarized results of three public meetings. Terry reviewed the new trail ideas suggested by the public. Committee felt several new ideas were a low priority: trail bordering USH 14 Kennedy to County institutions using "cow crossing" to cross USH 14 (doesn't connect to much) and trail from Mocha Moments to Pick 'N Save (doesn't connect to much);

Wuthering Hills connection through greenbelt to USH 14 could provide a grade separated crossing at existing bridge; connection from trail to Henke Road in Milton

Of projects in the current Plan, making the connection between the STH 26 overpass and the existing Glacier River Trail is the priority voiced by the public and committee. The City of Janesville has all of the needed easements and property in place to make the west side connection from Rockport Park to Parker High School. The City can also make the connection from Sandhill to Rotamer Road. Other trail projects will be development/redevelopment driven, such as downtown connections and NE Regional Park extension.

3. Recommend on-street improvements

Terry summarized on-street recommendations from 2005 Plan. Comments on existing recommendations:

Read Road: good local road connection with low volumes of traffic

Mineral Point: important connection because of high school. There might be some engineering issues around Franklin Middle School area.

Mt. Zion: medium priority

Kellogg: high priority because it would connect existing bike lanes as well as serve U Rock. Planned dormitory will increase need for accommodation.

Pontiac: high priority because of the Ryan road connection. There might be parking issues in front of Marshall/Monroe that will need to be addressed.


Crosby: there is an issue with the narrowness of the rail bridge. Arch may be a better option.

Terry presented ideas for additional bike accommodations. A road diet for the portion of E. Milwaukee that is 4 lanes undivided was seen very favorably by the committee. A road diet would connect two existing stretches of bike lanes, would calm traffic, and provide a direct link to the downtown. A road diet for Memorial between Milton Ave. and the bridge would be beneficial to the residences. It seems some of the traffic generators have gone away with the closure of Parker Pen and the relocation of Dean Clinic. A road diet on W. Court Street was not seen as favorably due to lack of destinations.

Other comments: use signage to make connections, talk to City of Madison about how road diet on Sherman Avenue has worked

8. Approval of May 5, 2014 meeting minutes

On a motion by member Mumma, seconded by member Woodard, the minutes of the May 5th meeting were unanimously approved.

9. New Business

11. Review and approval of amendments to the 2014-2019 Transportation Improvement Program

Terry Nolan summarized the projects. Sharon and Milwaukee bridges have long been in the TIP as Not Programmed waiting for funding. They are now receiving Bridge funding. An amendment to the 2014 TIP is needed in order for the City of Janesville to begin the projects this calendar year.

Member Woodard made a motion to approve amendments to 2014 -2019 TIP, with a second by Member Hulick. Motion unanimously passed.

12. Review and approval of 2015-2020 Transportation Improvement Program

Terry Nolan summarized the TIP projects. Member Mumma discussed the need for transit capital assistance, which is not provided for in MAP-21. He stated a meaningful reauthorization is needed.

Ryan pointed out edits and corrections needed to the map, and asked about the timing of project 371-11-003 USH 14: Lexington to Pontiac reconstruction. Terry will check with WisDOT on the project.

Terry explained that delay in construction of Ruger Ave. from 2018 to 2019, which was requested by Rock County, will affect the MPO's 2015 STP allocation, unless the MPO programs another project to use the \$907,865 within the 2014-2018 funding cycle. Austin Road design is underway and could be let for construction in 2017. Member Woodard said any additional funding leftover in the next cycle after funding Ruger construction at 80% should be directed toward Austin construction.

Member Woodard made a motion to advance Austin Road to Programmed using the \$907,865 in STP-Urban funding from the Ruger Avenue project, and for Ruger Avenue to be funded at 80% with the next allocation of STP Urban funding that will become available in 2015. Second by Member Coopman. Motion passed unanimously.

Member Woodard made a motion to approve the 2015-2020 TIP as amended and with suggested edits.

Seconded by Member Payne. Motion passed unanimously.

13. Review and approval of 2015 Work Program

Terry Nolan summarized the major activities of the 2015 Work Program. Member Mumma said City Administration has expressed interest in seeing Google Transit implemented, and administration may desire to see it become more of a priority. It may be necessary to hire a consultant to finish the implementation. Dwight McComb said Milton's GIS may not be an eligible activity. Members discussed using the funding from the GIS budget item for the implementation of Google Transit. McComb will check on the eligibility of both items. Member Woodard made a motion to approve the 2015 Work Program subject to federal eligibility. Member Robinson seconded. Motion passed unanimously.

14. Review of Draft Freight Section of 2015-2045 Long Range Transportation Plan

Terry Nolan explained that the Freight Section is a very rough draft at this point and there is more detail to be added before it is adopted in May 2016. Nolan asked members to provide feedback and direction, but no adoption at this time. Member Coopman praised the air freight component because of the importance of the airport. He then discussed the discontinuity of truck routes and limited designated truck routes and lack of connections between the urban and rural system. Coopman suggested a system wide map.

Member Arndt asked about a construction project he is seeing along STH 11. Member Cherek explained that the project he is seeing is where the future extension of Progress Drive will be, although the work right now is not road construction. The future road will be a right in, right out only. Member Arndt expressed a desire for the MPO to enact a policy to maintain STH 11 as a very limited access highway. Cherek said the state controls access.

Nolan said one stakeholder she interviewed brought up the issue of too large/heavy trucks on rural roads and she would like to learn more about the issue from the County and townships. Member Meyer said big trucks are an issue in Town of Milton. Members discussed Act 377 related to Implements of Husbandry (IOH) permitting process. Towns Association is trying to get uniformity of policy.

10. Communications from members.

1. Nolan updated the committee about the progress of the LRTP. She gave an overview of the changes to the Goals & Objectives, progress on Bicycle/Pedestrian section, update on Transit and Streets & Highways. Member Coopman asked what Milton residents felt should be the priority. Nolan replied the gap between STH 26 overpass and the Glacial River Trail parallel to the STH 26 highway was the priority expressed most often by all stakeholders, and Milton residents in particular felt that should be a priority. Member Mumma commented that the Transit Section of the LRTP should integrate the findings of the STH 26 transit corridor study.

11. Matters not on the agenda

1. Member Mumma mentioned Iowa Pacific Holdings is a privately held company exploring the possibility of privately funded passenger rail service between Chicago and Madison using WSOR owned railroads. There have been 4 or 5 trips in September/October. Mumma stressed the service is exploratory.

16. Discussion and possible action

Terry Nolan summarized the purpose of the meeting and projects proposed for modelling. Nolan explained that WisDOT does traffic forecasting with the Rock County model for the Janesville Area MPO, and that it is considered a reliable model.

Member Arndt suggested omitting the proposed new connection from the Avalon Rd/I-39/90 interchange to 11/14 E from Package 1. He stated the new connection would not be needed if the 11 bypass were not extended to 14 (proposed West Side bypass). Member Ryan stated he believed the state's intention in making the connection had to do with making a straight route to for HWY 11. Members discussed the purpose of the connection from the Avalon Rd/ I-39/90 interchange to 11/14 East and asked WisDOT to respond based on the State's study. Member Koprowski will get response from WisDOT and report back to MPO. Group agreed to eliminate the Avalon Rd/11-14 connection from Package 1 in which the West Side Bypass is not included in 2050 projection.

Member Arndt asked why the loop road to serve Shine does not extend to USH 51. Gale Price replied that the road will not connect to USH 51 due to Shine's security needs.

Member Coopman suggested ranking the projects in order of priority and creating scenarios based on the priorities. Nolan explained the reasoning behind the three scenarios presented is to separately test projects that may be considered controversial. Members and WisDOT staff discussed Rock County model in which local improvements will have less impact on the region. Member McComb asked if fiscal constraint was considered when project list was developed. Nolan replied that fiscal constraint was not a consideration.

Member Hulick requested the Sunset Drive project extend to Old 26/Janesville Street. This would make a key east-west connection on the north side of Milton.

Member Meyer is concerned with increased traffic on Townline Rd. between HWY 51 and STH 26. The road is a class B highway getting a lot of class A traffic. Members discussed possible need to upgrade the functional class to collector, and Member Coopman suggested need to upgrade the roadway to a better two lane roadway with shoulders. Nolan suggested upgrading the roadway in the future year model.

Member Sweeney suggested adding a grade separation at the railroad crossing at Kennedy Road and HWY 14. He also suggested a grade separation at STH 11 and HWY 51.

After discussion, Member Payne made a motion to adopt the project listing presented by Nolan with the following changes:

- Add grade separation at railroad crossing at Kennedy Road and HWY 14;
- Add grade separation at STH 11 and USH 51;

Member Arndt, Town Chair of LaPrairie and Member Bergman, Town Chair of Harmony expressed concern with recommendations for paved shoulders on town roads, specifically Read Road, Harmony Town Hall Road and Townline Road. These roads are currently recommended for a paved shoulder if the road is reconstructed to rural standard or bike lane if the road is reconstructed to urban standard. Members Arndt and Bergman are concerned with the cost of adding a paved shoulder, and requested a change to the recommendation. Committee discussed state policy regarding accommodations and whether showing the recommendation in the plan would require construction. State policy is currently unclear due to recent state budget repealing Complete Streets legislation.

Member Arndt would like to see Read Rd. designated as a bike route, recognizing it is used by experience cyclists, but not planned for alteration. Member Coopman made a motion to direct MPO staff to develop language to define planned route versus designated route. Motion seconded by Member Woodard. Motion carried unanimously.

Member Robinson requested the addition of the Crossridge Park Trail to the list of short range projects. This trail would be within Crossridge Park on the south side of Milton and would connect the neighborhood to the north to the park and the YMCA. It would also serve as an off road accommodation along Parkview Drive.

2. Presentation and review of Transit Section of 2015-2050 Long Range Transportation Plan

Nolan provided a summary of the transit section of the plan. Member Paynter asked if the plan covers passenger rail. Nolan replied the transit plan does acknowledge the growing demand for regional transit options. The plan summarizes the results of the Southwest Commuter Transportation Study completed in 2008, which concluded insufficient demand existed for passenger rail at that time.

Member Smith clarified the estimate for federal capital assistance is not an annual amount, rather JTS might expect to receive a larger sum in some years and little or nothing in other years.

3. MPO bylaw amendment

Nolan explained this change was simply to update staff positions. Member Woodard made a motion to adopt revised bylaws, with a second from Robinson. Motion passed unanimously.

5. Communications from members.

- Nolan updated the committee on the progress with the traffic forecast. Nolan worked with WisDOT to make functional classification changes in the Milton area for the purpose of the forecast. The feedback from WisDOT regarding the new alignment for highway 11 from the Avalon interchange to HWY 11 East is that the project would make the most sense if the west side bypass were built, although it could be a standalone project. Tom Koprowski, SW Regional WisDOT planning, recommended testing various scenarios with or without the connection.
- 2. Nolan informed the committee that the air photos taken this spring are not useable because they were taken too late. She passed around some samples. The MPO will carry over the funding from this year into 2016 and complete the project in early 2016.

6. Matters not on the agenda

Member Meyer mentioned the need to think long term about Townline Road. Nolan advised the project will not be included in the Transportation Improvement Program because it is a 6 year plan but that the project will be analyzed in the Long Range Transportation Plan.

Duane Cherek asked when the next MPO meeting will be. Nolan replied the annual meeting is held in early October to approve the TIP, Work Program, etc., but a meeting in September may be necessary as well.

7. Adjourn

On a motion by Member Payne, seconded by Member Meyer, the August 11the meeting of the Technical Advisory

Committee adjourned at 11:05.

III. Approval of August 11th meeting minutes

Minutes were corrected to reflect the attendance of Paul Woodard. On a motion by member Payne, seconded by member Smith the minutes of the August 11, 2015 meeting were unanimously approved.

IV. New Business

1. Approve amendment to 2015-2020 Transportation Improvement Program

Terry Nolan, MPO Coordinator, gave a summary of the projects. Member Payne said the cost estimate for the TEA grant for CTH G has increased to closer to 2 million. Nolan will make the correction for the Policy Board meeting. Member Smith made a motion to approve the 2015 TIP amendment, with a second by Robinson. Motion passed unanimously.

2. Review and approve 2015 Surface Transportation Program Allocation

Nolan provided a summary of the recommendation for programming the 2015 STP allocation, which includes adding funding to the Austin Road reconstruction and funding design of Ruger Avenue at 80% and design at 50%. It is in the MPO's best interest to spend the allocation as soon as possible, because projects can affect the next allocation of funding. However, projects must be approved for scheduling by the state and the state has indicated Ruger design may be scheduled for 2016. The recommendation in the memo is reflected in the 2016 TIP and the TIP also contains projects that could use STP funding in future cycles. Member Woodard made a motion to approve the STP allocation funding, with a second by McCue. Motion passed unanimously.

3. Review and approval of 2016-2021 Transportation Improvement Program

Nolan gave a summary of the 2016 TIP. The TIP reflects a two year delay of the I-39/90 reconstruction, additional STP funding for Austin and funding for Ruger as outlined in the STP memo, three trail projects are included that the MPO plans to submit applications for, and the TEA grant for CTH G. Member Ryan questioned the timing of project #12 reconstruction of USH 14 from Lexington to Pontiac. Nolan will check with WisDOT. Member Woodard made a motion to approve the 2016-2021 TIP with a second by Robinson. Motion passed unanimously.

4. Approve amendment to 2015 Unified Work Program

Nolan explained need for amendment to the 2015 Work Program stems from unacceptable air photo that was contracted this year. The funding will be carried over into 2016 and will be completed next year. Woodard made a motion to approve the 2015 Work Program, with a second by Robinson. Motion passed unanimously.

She recommends the following for further consideration: West Side Bypass, 11/14 expansion east, new connection from Avalon Rd. to 11/14 East.

Member Gunn questioned why the West Side Bypass would be included in the Plan given that the project was dropped. Member Woodard replied that it wouldn't be reflected as a recommendation but only as a study. Member Arndt suggested grouping the West Side Bypass with the Avalon to 11/14 connection because the two projects are tied. The group discussed how to limit/restrict access along future highways. Group agreed the Plan should include access control language for study recommendations.

Member Meyer and Member Hulick suggested the Townline Rd. project extend from USH 51 to Henke Rd. to address projected increases in traffic in this north side area.

Members discussed Milton Ave. deficiency from Memorial to Kennedy/Randall. Group decided to make the project a recommended future expansion project. Member Woodard made a motion to accept the list of projects with the changes made by the committee, seconded by Meyer. Motion passed unanimously.

III. Review and approval of March 14, 2016 meeting minutes.

Motion by Sweeney, second by Deupree, minutes were approved 8-0-0 with members Jorgensen and Williams abstaining.

IV. New Business

- 1. Review and approve amendments to 2016-2021 Transportation Improvement Program Terry Nolan, MPO Coordinator, summarized the amendment to the TIP. Member Marklein made a motion to adopt amendments to the 2016-2021 TIP, with a second by Member Liebert. Motion passed 10-0-0.
- 2. Review and approve 2015-2050 Long Range Transportation Plan

Nolan gave an overview presentation of the LRTP. Harmony chair mentioned Townline Rd. is partially reconstructed already and upgraded to Class A, therefore largest concern is between CTH Y and 51. Member Bergman also did not see the town participating in expansion of Town Hall Rd. Nolan explained the Town Hall Rd. project is identified as a Surface Transportation Program project, which would cover 80% of the cost. The project would likely occur as a cooperative agreement to transfer to roadway to City of Janesville jurisdiction.

Member Sweeney asked about what freight data would be useful for planning. Nolan replied truck counts and rail tonnage data from all rail companies are data sets the MPO would benefit from. The MPO may wish to collect truck traffic count data, or coordinate with WisDOT on a statewide program. Member Sweeney asked for clarification that grade separated crossings for rail in Janesville were included in the plan. Nolan confirmed the Five Points intersection and the crossing at USH 14 are included as projects recommended for further study.

Chair Marklein opened the meeting up for public comments. Dave Hyde, 1315 Mineral Point, representing the Center for the Blind and Visually Impaired and the Federation of the Blind, spoke on behalf of transit. Mr. Hyde wondered if the goal for increasing ridership was .08 percent or .008 percent. Nolan said she and Transit Director Smith would look into it.

Mr. Hyde asked the Plan consider technology and expansion opportunities – particularly for Saturday evening and Sunday. Mr. Hyde suggested shared ride taxi may work well for Saturday evening and Sunday service.

Member Liebert asked about backup projects in the plan. Nolan said there are some projects – like Kellogg Ave. – which are identified as backup. Member Marklein asked about environmental justice and how projects could negatively impact populations. Nolan explained negative impacts of projects may include air quality or noise impacts, and mitigation may include noise walls.

Member Williams made a motion to adopt the 2015-2050 Long Range Transportation Plan, with a second by Member Sweeney. Motion passed unanimously.

3. Review and forward comments regarding Environmental Impact Statement Draft Scope of Study being prepared for the Great Lakes Basin Rail Line

Cherek gave a brief overview of the item. Member Sweeney noted the letter in the packet is amended to incorporate changes the board requested. Member Bergman agreed with Member Sweeney.

Chair Marklein asked if anyone in the audience wished to speak. Brad Maher, 638 S Gammon Rd., Rock Against the Rail, organized to find alternatives to the Great Lakes Basin Project. Maher wondered if the Union Pacific railyard could be used for ancillary switching and coordinating rail cars. Ken Lucht, WSOR, let the audience know he was in attendance to answer questions. WSOR has not taken a position on the project. Lucht stated the Great Lakes proposal is to create a bypass for hazardous materials and crude oil. The premise of the project is to bypass urban areas, but railroads connecting to the bypass could see an increase in hazardous materials shipments, which would impact urban areas. Member Deupree wondered if existing railroads are talking to the Chicago effort. Lucht did not know if the Great Lakes Basin is coordinating with CREATE, a strong public-private partnership that is working on the congestion in the Chicago area.

Mr. Maher added Union Pacific has withdrawn support of the Great Lakes Basin proposal. It was his understanding as well that the purpose of the proposal is to transport crude oil.

Member Liebert made a motion to forward the comments to the STB, Member Jorgensen seconded. Motion passed unanimously.

I am unable to attend the meeting that us being held on 3 15 16 at 70m in regards to the city council teminating jts night side routes but would still like to state my opinion and concerns

First you say there is not enough ridage.

Granted it may not be as busy as it is during the day time routes but when i ride at night there is usually more than 4 to 5 people on. Yes later in the evening it is lower ie the 9:15 run. But it does get used esp the 6:15 and 7:15 runs. Maybe instead of completely teminating it you can come up with a compromise and have it run til 8:15 ie the last bus out would be 8:15 returning to transfer piont @9:15 no more buses after that.

Second. Alot of people who rely on the bus to get to and from work may need the 6:15 and 7:15 bus to get home from work. If this is cut you could be jeopardizing people job and hence increasing unemployment rate. Possibly keeping the buses running a little later but not as long as they are now will help keep these individuals employeed.

Third. A lot of disabled individuals use the night side routes to enjoy interacting with the janesville community getting out and socializing participating in city events. If they don't have transportation they will not be able to continue doing this. This also fall under number two as these individuals rely on the buses to get home after work when they work. If their shift runs into the early evening they general take the night side routes to get home.

Also providing night side service helps disabled individuals to be more independent.

I understand that with not enough ridage it is costing the city. And as a city council you need to take that into account. But I also feel as a city council you need to take into account how this affects all the residents of janesville.

I have heard it said that the city would like to get the disable more involve in city events but by limiting their opportunity to get to these event independently through city transportation. Is not going to help or get disabled individuals more involved it's going to hinder it. If you want the disable community to be more involved you need to provide the means for them to do so and one way Is to a least not completely eliminate the night side routes. Cone up with a compromise I am a visual impaired individual who works full time and takes the bus to and from work as well as to do things within the community in the evenings. This includes being able to attend my childrens school activities such as concerts and conferences. And school night time events without night side routes I will not be able to do this which not only affects me but my children. And I will not hesitate if they ask to let them know that because city council decided that night side bus routes were not providing enough money they decide to eliminate that service hence making me unable to a tend your concerts and conferences. Like I said I know you need think about the bottom line but please take into consideration all the other things this decision may affect.
